

# oneXRM Platform PRIVACY NOTICE



Welcome to our privacy notice. We're OneXRM Ltd, a private limited liability company with registration number 12518824. We're a company that respects your privacy and is committed to protecting your personal information. This privacy notice sets out how we look after your personal data when you visit our website and tells you about your privacy rights and how the law protects you.

We collect, process, use, and are responsible for certain personal information about you. When we do so, we are regulated under the General Data Protection Regulation (EU) 2016/679 (the GDPR), which applies across the European Union, the EEA, and in the UK, and the Data Protection Act 2018 (the DPA).

For the purpose of the DPA, we are the data controller, which means we're responsible for your personal data. We are registered with the Information Commissioner's Office (registration number ZA851940) (the ICO), the UK supervisory authority for data protection issues. You have the right to make a complaint at any time to the ICO.

## WHAT INFORMATION DO WE COLLECT?

Below is a list of types of personal information that we may collect and use:

Type of personal information	Description
Contact	Your name, addresses, email addresses, phone numbers, and other ways in which to contact you
Financial	Bank and/or credit card information provided by you in connection with the services we provide to you
Contractual	Details about the services we provide to you (and about the services you provide to others - i.e. your data may be processed for the purpose of generating and creating contracts with other users of the oneXRM Platform)
Location	Data we obtain about your location. This may come from your mobile phone or the place where you connect a computer to the internet, or you may share with us



Technical	Details on the devices and technology you use
Communications	What we learn about you from communications between us
Public and third- party records	Details about you that are in public records, such as the Electoral Register and Companies House. We also collect information about you which we receive from other companies such as (without limitation) identity verification and fraud protection agencies for anti-money laundering and fraud prevention purposes
Usage data	Data about how you use our services
Documentary data	Details about you that are stored in documents in different formats (or copies of them). This could include things like (without limitation) your passport and driving licence
Consents	Any permissions, consents, or preferences that you give us

We will employ adequate organisational and security measures to protect your personal information. We will use reasonable efforts to ensure that your personal data is accurate, complete and up-to-date. Please ensure you notify us without undue delay of any changes to the personal data that you have provided to us by contacting us at the details provided in this privacy notice.

#### HOW DO WE USE YOUR INFORMATION?

We will only use your personal data when the law allows us to do this.

Most commonly, we will use your personal data to:

- let you know when we make changes to our services;
- manage our website and customise it according to your interests;
- handle internal matters, such as record keeping, troubleshooting, data analysis, testing, and research;
- let you take part in interactive features on our website and/or platform (i.e. generating and creating contracts with other users of the oneXRM Platform);
- provide quotations;
- identify and prevent crime (i.e. identifying, investigating, reporting, and preventing fraud, money laundering, and other crime)
- market to you through third parties; and
- help keep our website safe and secure.



We will ask for your consent before using information for a purpose other than one listed above.

#### HOW DO WE SHARE YOUR INFORMATION?

The types of third parties we share your personal data with include:

- Operational software providers
- CRM providers
- Financial and payment processing providers
- Our website host
- Analytics and search engine providers
- Other organisations, if required to do so for legal or regulatory reasons

We don't share your data with anyone else without telling you and we definitely don't sell any data either.

#### **WHERE DO WE SHARE YOUR INFORMATION?**

If we ever need to share your information with anyone else, we'll make sure they have similar rules in place to store your data securely and that they comply with the EU Commission's Standard Contractual Clauses when it comes to data protection.

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.
